Definitions

We / Us: Refers to Clinical Perspectives.

Website: Refers to clinicalperspectiveslv.com and any of its subdomains.

Cookies: Small data files stored on your device to enhance user experience.

Log Files: Records of user activity on our website, including IP address and browser details.

Personal Information: In this policy, *Personal Information* refers to both *Device Information* and *Provided Information*.

Device Information: Information automatically collected from a user's device during a website visit. This may include the IP address, browser type, time zone, pages viewed, referring websites or search terms, and details about interactions with the site.

Statement of Purpose

The purpose of this policy is to describe how Clinical Perspectives (“we” or “us”) collects, uses, and shares your personal information when you use our website clinicalperspectiveslv.com and any of our subdomains (the “Website”). It aims to protect your privacy and handle your information in accordance with applicable laws and regulations.

Policy

This Privacy Policy applies to all users of Clinical Perspectives website, clinicalperspectiveslv.com, and its subdomains. It supervises how we collect, use, disclose, and protect your personal information when you access or interact with our site.

Clinical Perspectives is committed to safeguarding your privacy and handling your information responsibly in accordance with applicable data protection laws, including Nevada Revised Statutes (“NRS”) Chapter 603A.

This policy outlines the types of data we collect, the purposes for which we collect it, your rights regarding that data, and how you can contact us with questions or requests.

This policy is subject to change at any time without advance notice. All revisions replace earlier versions of the policy and take effect immediately.

Required Acknowledgment

By reviewing this policy, I acknowledge that I have read, understood, and agreed to comply with its terms and conditions.

Personal Information We Collect

When you visit the Website, we automatically collect certain information about your device, including details about your web browser, IP address, time zone, and some cookies installed on your device. Additionally, as you browse the Website, we collect information about the individual web pages you view, what websites or search terms referred you to the Website, and information about how you interact with the Website. This type of automatically collected data is referred to as *Device Information*.

Device Information is collected via cookies, log files, web beacons, tags, and pixels for the following purposes:

- **Functionality:** To recognize you on our website and acknowledge your previously selected preferences, including your preferred language and your location.
- **Advertising:** To collect information about your visit, the content you viewed, the links you followed, and information about your web browser, device, and IP address. We sometimes share limited aspects of this data with third parties for advertising purposes.

You can set your browser not to accept cookies. Some of our website features may not function if you disable cookies. Please note that we do not alter our website's data collection and use practices when we see a 'Do Not Track' signal from your browser.

We also collect and process information that you provide to us directly (such as name, email address, phone number, etc.), including when you:

- Register online for any of our services
- Voluntarily complete a customer survey or provide feedback on any of our message boards, via our contact form, or via email
- Provide your email address in exchange for access to a free resource
- Sign up for our email newsletter or subscribe to any of our regular content
- Submit an intake form or application form for any of our services or programs

How we use your Personal Information

Provided Information may be used to:

- Communicate with users
- Respond to inquiries or feedback
- Share updates, promotions, or information about services in line with user preferences

We may also include affiliate links to third-party websites where products can be purchased. In such cases, no payment or order information is collected or processed directly by Clinical Perspectives. Instead, referral tracking may be used to recognize affiliate partners and, if applicable, issue commissions for purchases made through those external sites.

Device Information is used to help identify potential fraud or security risks (such as by analyzing IP addresses), and more broadly to optimize website performance, monitor visitor behavior, and assess the effectiveness of marketing efforts.

How we share your Personal Information

We share your *Personal Information* with third parties to help us use your information, as described above.

The types of third parties with whom we might share elements of your *Personal Information* include:

- Providers of email management and distribution tools
- Providers of security and fraud prevention tools and services
- Providers of data aggregation and analytics software services that allow us to monitor and optimize our site effectively
- Providers of affiliate marketing tracking and analytics tools, which allow us to generate referral links, track user interactions, and issue commissions to affiliate partners
- Providers of client management systems to help us track and communicate with potential clients

We may also share your *Personal Information* to comply with applicable laws and regulations, to respond to a subpoena, search warrant, or other lawful request for information that we receive, or to protect our rights and interests.

How we store your data

We process and store your data using Wix.com.

You may refer to Wix's website for information about where their servers are located and how your data is stored.

We employ commercially reasonable security measures to protect against unauthorized access to, or unauthorized alteration, disclosure, or destruction of, any information that may be stored on our servers. Of course, no computer network or data transmission on the internet can be guaranteed to be 100% secure; therefore, you submit your information at your own risk.

We will maintain your personal information for our records, unless and until you request that we delete it.

Email Marketing

If you download a free resource from our website or opt in to receive emails, you agree to receive email communications from us. These may include newsletters, site updates, promotions, and other announcements. We are not responsible for the delivery of these emails, and it is your responsibility to ensure that our email address is not blocked or sent to your spam folder.

You may opt out of our marketing communications at any time. Please note that if you unsubscribe from our emails, you may no longer receive important updates, promotions, or other information related to our website.

Behavioral Advertising

As described above, we use your *Personal Information* to provide you with targeted advertisements or marketing communications we believe may be of interest to you.

Your Data Protection Rights

You have the right to access the personal information we hold about you and to request that it be corrected, updated, or deleted. Under certain conditions, you may also have the right to restrict or object to our processing of your data, and to request that we transfer your Personal Information to another organization.

To exercise any of these rights, please contact us using the information provided in the ‘Contact’ section below. We may need to verify your identity before fulfilling specific requests.

We comply with applicable Nevada privacy laws, including provisions under NRS Chapter 603A, which require us to implement reasonable security measures to protect personal information collected from Nevada residents. While we do not sell personal information, we are committed to handling your data responsibly and transparently.

Third-Party Websites

Our privacy policy applies only to our website. We are not responsible for the data collection, privacy practices, or policies of any third-party site to which we may provide a link or that may link to our site. We encourage you to read the privacy statement and terms of use of other sites.

Complaints
